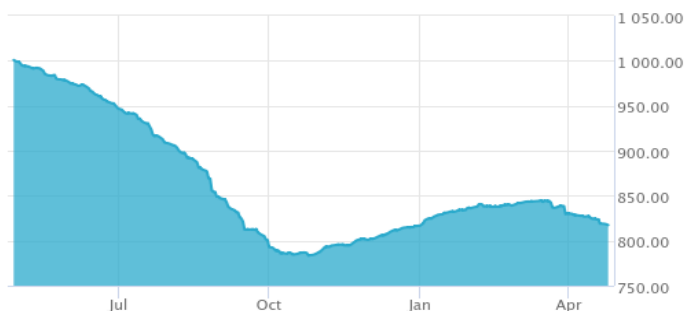


# Universal Standard Diamonds Evaluation 100 Index
