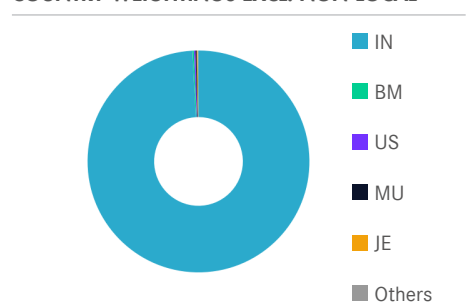

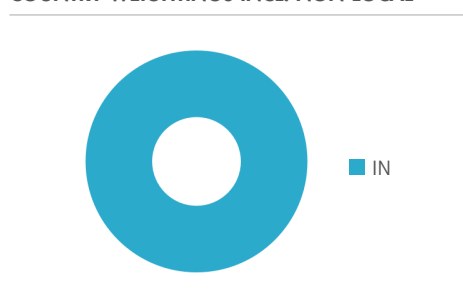

COUNTRY WEIGHTINGS EXCL. NON-LOCAL*



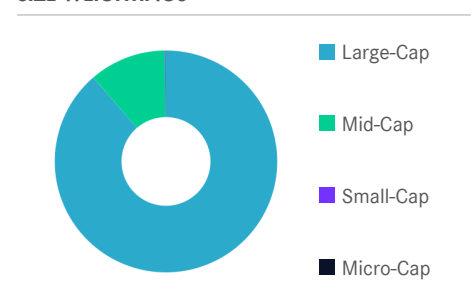

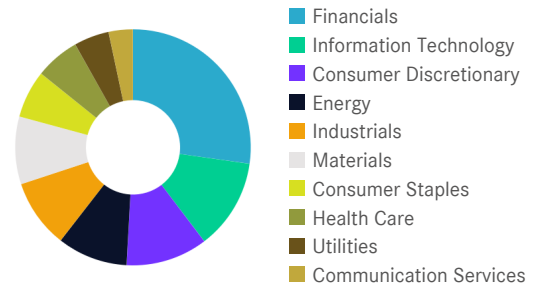
